





I would like to take this opportunity to congratulate you for the quality and efficiency of the work performed by Tridome and thank you and your team for a job well done.

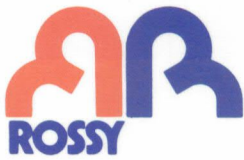
